- Make all applications in at least **2 gallons of water per 1,000 ft<sup>2</sup>**
- Allow the **spray to dry before irrigation or rainfall**
  - **Irrigate prior to the next mowing** with at least 0.1" of irrigation
- Claims must be filed by **October 1, 2023**
- If a breakthrough occurs, it is at the Syngenta territory manager's discretion as to what product is provided for rescue treatment and whether the rescue treatment application is broadcast on all acreage or spot treated on affected breakthrough areas
- The Guarantee is limited to providing one recovery application, up to the total acres originally treated, and covers commercial and residential properties throughout the U.S.
