Application Instructions

This is a turf fertilizer. Apply evenly to dry foliage using the one or two pass application method. On a two pass application, criss-cross the area with half of the application rate per pass. Apply prior to or during favorable turf-grass growing conditions. **Note:** When temperatures are consistently exceeding 90° F, water immediately after application to reduce stress on your lawn. Brush or blow off any non-target areas to alleviate any staining or unwanted effects.
